- The CCA reception is a spot to carry forward a Saskatchewan view on the carbon tax.
- Communications to producers and consumers Video on crop insurance along with Twitter thread to get better uptake of information (vs awareness that something was announced).
- Home shows SSK done, Regina next week
- Strategy to manage potential industry disasters Marianne working on an event with the province to help be prepared.
- Professional and transparent organization Calls and visits to dealers about levy increase. LSS working forward on being ready to share their reports with SCA.
- The association is on a solid footing.
- BFO AGM was vey disappointing. Not the decisions being made but more in the information they were being presented to make those decisions. Will not be ready to increase the national check off any time this year and did not pass a provincial increase. Erroneous statements about how national agency budget works and how national check off can be used were just two issues.
- The Ministry is moving forward to allow lease land to be used a security. They are not above using this change as a tool to push lessees into buying some of the lease land if they decide to use it as security and to push pastures to buy improvements. This is a mixing of policy goals but a free way to do so for the government. They also are thinking of capping how many lease acres can be used as security recognizing there are some very big leases out there. They would like feedback on both issues.

"plans" don't necessarily match an event as it unfolds, but the connections, relationships and frameworks built to pay off. E. CRSB Consumer Research

Discussed the request from CRSB for funding of consumer research. Lack of detail in the request was noted, some research programs have been denied on the grounds of not having enough information like this.

Monica Hadarits joined the board via conference call.

They sent out a request for proposals. Got feedback. Goal of research Is to test different logos and claims to ensure they resonate with consumers and do not create false or misleading claims. First step is key informant interviews, then outline survey (important to have a representative sample of the Canadian population).

Intent is to do this with 1500 people and get feedback on logos and claims.

With that feedback have focus groups with 40 people to confirm and assess modifications.

So far funding has come from membership in CRSB. Also exploring provincial and federal gov't. It has come from across the categories. One producer, one retail, one food service.

Do we need another logo when we already have a Canada Beef logo?

CRSB is working closely with Canada Beef and the Council has given direction to create a consumer facing logo.

The framework allows for a pharmacy style retail for vet drugs, but it is up to the retailers to determine if this is a viable option for them.

In terms of communications, we propose to work with SVMA, determining the messaging they are convey to their vets, ensuring we communicate to producers what a VCR is and how it will work come Dec 2018. We will also do regular updates on the SSGA insert, e-blasts, FB and Twitter. This involve videos with vets, producers and govt officials. The national communications team of the issues management group is looking to be actively involved in communications around this issue.

Resolution #6:

"That SCA represent the "client" and be involved in defining and regulation the "vet client patient relationship" in SK"

Proposed Action:

According to the CVMA, a legitimate VCPR is considered to exist only if medical records of the veterinary practice contain evidence of relevant and timely interaction between the veterinarian, animal owner and animal patients. This may include: farm visits, consultations, direct animal examinations (individual or herd/flock), laboratory reports, production record reviews, etc. The VCPR is not a signed contractual agreement but rather a working connection and interaction between veterinarian, client and specific animal patient or group of animals. We will continue to monitor this. If there is a move by either the SVMA or others to open up the existing definition, we will be an active participant in the process. In addition, we are seeking the possibility of having someone from the SCA be the member at large on the SVMA board

Resolution #7:

"That SCA investigate possible grass attractants that would encourage severe grazing to reduce and/or eliminate the fuel load on grazing land where a fire break is desired"

Resolution #8:

"That SCA investigate appropriate insurance instruments to fill the gaps exposed by the disaster events of 2017"

This is being done. The new proposed fire coverage (taken with rainfall insurance) is a good step forward from the province.

"Be it resolved that the SCA continue to lobby the Ministry of Environment to be included in their CWD Wildlife Working Group to assist in the development of a CWD management plan that will be presented to government"

Proposed Action:

SCA has submitted a request to be part of this group. We won't know for a while if our application has been accepted as there is a process going on to secure an expert for the group. No decisions on membership will be decided until this is completed.
