### GENERAL ELIGIBILITY CRITERIA

- Candidates for induction must have made unique contributions, the acts for which they are recognized must have benefited farm families, beef producers and cattle production in the province of Saskatchewan.
- Nominations for couples to be considered for induction will use the same criteria as for individuals. The case must be made however that both members of the couple have contributed equally to the accomplishments.
- Nominations will be kept on file and reconsidered for up to two additional years. The nominator may submit additional information prior to the September 1<sup>st</sup> deadline in each of the subsequent two years. After being considered for three years, a new application will be required.
- This form must be used for nominations.
- Nominations must be received by December 20<sup>th</sup>, 2024, to be considered.
- Successful candidates will be notified by December 30, 2024. Inductees will receive complimentary tickets to the Saskatchewan Beef Industry Conference (SBIC) and banquet held January 28<sup>th</sup> -30<sup>th</sup>, 2024
