# F- Guests Wendy Wilkins and Judy Currie join the meeting via conference call.

- Wendy is disease surveillance vet and epidemiologist with Saskatchewan Agriculture.
- Judy Currie is registrar with SVMA. Was small animal practioner in Saskatoon and was in CFIA inspection for about 9 years.
- Currently working on a new bylaw for SVMA that would allow vets to fill scripts from other vets as is currently allowed in AB. Could take to another vet that is willing. Already have a pharmacy at the vet college in Saskatoon "so it already works." If they move forward with this bylaw, a clinic could email a scrip to another clinic for filling. Would need to keep record, ensure the scrip is from a licensed veterinarian.
- What about Maple Creek and Medicine Hat? This would be up to Alberta Vet Med Association, and to SVMA to decide if they recognize scrips from out of province veterinarians.
- Preceptorship program aims? Hope to keep some of WCVM SK students within the province. Know there are many single and even multi vet practices looking for sustainability. Aim is for third year students to go work with vets in those practices, see how good it can be and induce some to stay in when they graduate the following year. Only offered to SK pool students. Specifically to practices who are either in need or have been looking a long time. Also looking at the places they are going is with a vet that can give good mentorship and practice experience whale they are there.
- Hoping to find funding from others than SVMA and the vet. Hoping for donations from producers in those areas. RMs who want a vet clinic in their areas / SCA / Drug companies. They want to be able to pay the student \$10,000 for the work over the student split into thirds/ practice/SVMA and outside sources. If this is successful, they are looking to grow to 20 student pool from SK-not planning to use for small animals.

# Pat Hayes, Reg Schellenberg, Les Johnson

Reg / Pat— CCA AGM is coming up. Animal care & health committee meeting is morning of March 21, extended an invite.

Jill Harvie, Brady Stadnicki and John Masswohl met with Minister MacAulay about traceability and tag retention. Jill is trying to coordinate an opportunity for Reg, Pat, Dennis to meet with top end CFIA about intentions around Cattle Implementation Plan.

Plan is to take Mark Lawrence with them to help outline the issues with doing a snapshot of traceability 3 years from now without a baseline now to measure against. This is a bit of a new angle of just cost, his report compared CIP and the presumption of the regulations and poked holes in both. Brought the Minister up to speed as well.

Talked to the Minister regarding holes in CIP, including if load lot movement, taking manifests, how do they move into the Canadian Livestock Traceability System. The cost is estimated at \$1 million in salary costs plus some software upgrades to CLTS. Made the point to the Minister that there needs to be someone besides tag buyers paying for things.

Passed resolution about gaining information about lost or stolen cattle. Eric Aubin responded that the genesis of the issue is that brand inspectors are not recognized as an investigative body under the Privacy Act.

RCMP can already get that information, CCIA pulls it as soon as the request is made, when the federal government clears the RCMP to accept the information CCIA gives it to them immediately.

Brand inspectors would need to whittle it down to a hierarchy that does not let just anyone call CCIA to get that information.

Most lost animals are solved easily by calling CCIA and they all the owner of that tag. The desire to short circuit it and allow the communications to go straight across makes it more difficult.

CCIA bylaws say there is a 12 year sunset clause for directors - Some members want it to stay the same. Need for renewal remains.

# Budget for CCA seen before March AGM?

53 cent charge per head marketed will be the amount charged for CCA's budget and it will stay flat as it has been for five years. Pat voiced support for 55 because 53 will be very slow reserve building amount. Other provinces said they could not sell more that that. This will be a five - year period.

Executive – last year Pat was appointed and Reg was elected. Reg is willing to stand again.

### Les Johnson: CRSB participation

Thanked the board for allowing him to represent on the verification committee. Both the verification and indicator committees have met their commitment and have been disbanded.

Talked about Monica about the volunteers they are looking for. Committee would resolve complaints / appeals / conflicts around requirements and implementation. Deal with problems that would arise out of the program. Two- year term. 11 members on the committee from the CRSB registered members. Room

for 3 producer reps. They have 2 memberships willing to fill 2 spots. So one spot is open. Review into the program in three years, likely expecting a couple of terms.

Duane Thompson: Co-chair of CCA Environment Committee.

Oak Lake Marsh meeting with ENGOs sounded like they would all put together a generic beef industry endorsement. When they went back to their own boards it was not so simple as all that. Larry Thomas is filling Fawn's position on a contract while she is on a six-month sabbatical. Kathy Larson Needs to have full support to get the job done at the LFCE.

### Chad Ross - Canada Beef:

Approved the budget the past couple of days. Approx.\$500,000. With an estimated 1.4 million slippage. Due to the separation between marketing and agency there will be some added costs (financial staff). Cash flow too. At points in time the agency will be \$300,000. In the negative. In the past that has come from marketing. Now to show separation, either will have to get an operating loan or other facility. Canada Beef will still cover the negative but Agency will pay interest. Piggy backing on offices and staff will no longer happen. Canada Beef will charge for space, copy machines, admin assistant for meetings, ect.

Melinda and Tayla are only 2 employees of the agency. Will add some costs to share a book keeper, interest on operating loan.

Canada Beef – Francis has been building bridges with Tom and Dennis. Business plan rolled out to Marketing Committee. Francis has shown good creativity with available budget.

Issues Management – not receiving any Agency money any more. Will be receiving allocation.

BCRC – Met day before SBIC – business meeting. Service agreements, bylaws and budget. Little on tech transfer and research. McAllister work on antimicrobial resistance looks very promising for our industry.

They will fence and want grazing, maybe lease. That land is called Occupied Crown Land and the rules on hunting access is still up in the air.
- There were motions that none of the land be grazed. They were not supported except by the movers. There were several that recognized the need to work with ranchers
- Hunting access SWF wants to work with us.
- They will be reaching out on CWD, access to land, grazing.
- Ministry of Environment has developed a Game Management Plan, Chris is looking through and putting before the Regulatory Working Group. They want more feedback from people on the land. Talking to landowners has to be part of it.
- TIPS line board has an opening. Not in mandate.
- Paul James researches disturbance on land. He may come forward with proposals.
